



**WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT (RELEASE)
2020 Summer Strings Virtual Camp**

In consideration of my child being allowed to participate in the 2020 Summer Strings Virtual Camp, conducted by NAT KING COLE GENERATION HOPE, Inc., from July 20 to July 24, being held online in google classroom and google meet, I the undersigned, to the fullest extent permitted by law, hereby voluntarily assume all risk and do release, discharge, waive and relinquish any and all actions or causes of action for personal injury, property damage, or wrongful death occurring to my child as a result of my participation in the Summer Strings Virtual Camp and/or any activities incidental thereto wherever or however the same may occur. To the fullest extent permitted by law, I, for myself, my heirs, executors, administrators, and assigns hereby release, waive, discharge, and relinquish any action or causes of action, aforesaid, which may hereafter arise for me and/or for my estate, and agree that under no circumstances will I or my heirs, executors, administrators, and assigns prosecute, present any claim for personal injury, property damage or wrongful death against NAT KING COLE GENERATION HOPE, INC., its facilities, or any of its trustees, officers, instructors, employees or agents (RELEASEES), for any of said causes of action, whether the same shall arise by the negligence of any said persons or otherwise, including participating in the Summer Strings Virtual Camp, or while in, on, upon or near the premises where the Summer Strings Virtual Camp is being conducted.

IT IS MY INTENTION BY THIS INSTRUMENT TO EXEMPT AND RELIEVE NAT KING COLE GENERATION HOPE, INC. FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, AND WRONGFUL DEATH. I further hereby agree to indemnify and hold harmless RELEASEES, to the fullest extent permitted by law, from any loss, liability, damage and costs including court costs and attorneys' fees, that they may incur due to my participation in the Summer Strings Virtual Camp, whether caused by negligence of RELEASEES or otherwise.

My child has no physical condition that would prevent them from participating in this event. My child is in good health and physical condition. I am fully aware that there are risks and hazards, known and unknown, connected with the Summer Strings Virtual Camp, and I voluntarily assume those risks and hazards connected with the Summer Strings Virtual Camp. I understand that I am responsible for obtaining treatment for any injuries sustained while participating in the Summer Strings Virtual Camp.

I give my full permission to NAT KING COLE GENERATION HOPE, INC. to use any photographs, videotapes, or other recordings that are made during the course of this event.

I expressly acknowledge that this RELEASE is intended to be as broad and inclusive as permitted by the laws of the State of Florida, and that this RELEASE shall be governed by and interpreted in accordance with the laws of the State of Florida, and venue for any legal proceeding or lawsuit shall be in Palm Beach County, Florida. I agree that in the event that any clause or provision of this RELEASE shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this RELEASE which shall continue to be enforceable.

IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I HAVE READ IT IN ITS ENTIRETY, UNDERSTAND IT AND VOLUNTARILY SIGN IT AS MY OWN FREE ACT AND DEED; THAT NO ORAL REPRESENTATIONS, STATEMENTS OR INDUCEMENTS NOT CONTAINED HEREIN HAVE BEEN MADE TO ME BY ANY OF THE RELEASEES; THAT I AM THE PARENT/GUARDIAN OF THE PERSON PARTICIPATING IN THE STRING CAMP; AND THAT I EXECUTE THIS RELEASE FULLY INTENDING TO BE BOUND BY SAME.
